

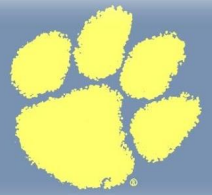

Alignment, assessment, and revision of the scope and sequence of instruction is an ongoing curricular process involving all instructional staff.***

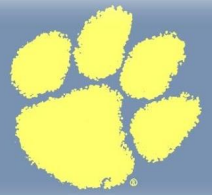

2. Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement. Specifically, those conferences will be held; ***Parent-teacher conferences will take place on Monday, November 22nd and Tuesday, November 23rd.***
3. Provide parents with frequent reports on their children's progress. Specifically, the school will provide reports as follows; ***The school will provide reports to parents at the conclusion of each Trimester. The I&RS committee and Child Study Team will coordinate***
4. Provide parents reasonable access to staff. Specifically, staff will be available for consultation with parents as follows; ***The staff will ensure regular, two-way, meaningful communication between family members and school staff, and to the extent practicable, in a language that family members can understand. The staff will schedule phone conferences, in-person conferences, and/or video conferences in a timely manner.***

- Read at least 30 minutes every day outside of school time.

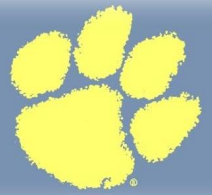

## **Additional Required School Responsibilities**

The Avon Elementary School will:

1. Involve parents in the planning, review, and improvement of the school's parent and family engagement policy, in an organized, ongoing, and timely way.
2. Involve parents in the joint development of any schoolwide program plan, in an organized, ongoing, and timely way.
3. Hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements, and the right of parents to be involved in Title I, Part A programs. The school will convene the meeting at a convenient time to parents, and will offer a flexible number of additional parent and family engagement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite to this meeting all parents of children participating in Title I, Part A programs (participating students), and will encourage them to attend.

7. Provide to each parent an individual student report about the performance of their child on the State assessment in at least math, language arts, and reading

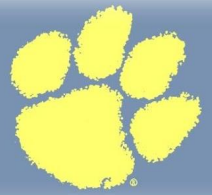
